- Charles "Chuck" H Horning, II, age 54, Townsend Township Fire Department, Oct 13, 2015. Fire Captain Horning was found deceased, slumped over the steering wheel of a vehicle, approximately eight hours after responding to a fire call with his fire department.
- Patrick R Wolterman, age 28, Hamilton Fire Department, Dec 28, 2015.
 Firefighter Wolterman died from injuries sustained when he became trapped in a residential structure fire. On January 4th, 2016, officials stated that the fire was due to arson and is being investigated as a homicide.
- Scott D. Bruggeman, age 45, Middletown Division of Fire, Jan 18, 2016. On March 18, 2014, Firefighter Scott D. Bruggeman suffered a heart attack while restraining an uncooperative patient in the Atrium Medical Center emergency room and underwent several heart surgeries. On January 18, 2016, Firefighter Bruggeman passed away from injuries sustained.
- Sandra M. Lesko, age 51, Willoughby Hills FD, January 24, 2016. Sandy was a Captain with Willoughby Hills Fire Department serving the community for over 25 years. Shortly after the 911 attack, Sandy and her dog Gondo volunteered for the recovery operations at Ground Zero in New York City. Her cancer resulted from her time working at Ground Zero.
- Michael Palumbo, age 47, Beachwood FD. Michael was a captain and paramedic with the Beachwood Fire Department, having served in the department for 24 years. He was also a part-time captain with the Willowick Fire Department, where he started his firefighting career in 1990. He was diagnosed with brain cancer in 2015 and passed away on May 24th, 2017.
- Kenny Ray, Jr. Fire Technician/Industrial Firefighter Ray, age 32, was found deceased at the corporation's Faircrest plant (Canton, OH) on March 20, 2016. According to company officials, Ray was checking fire extinguishers throughout the plant when members of the security team found him unresponsive in a fifth-floor elevator motor room. Nitrogen exposure/asphyxiation is suspected as a cause of his death. Ray also served part time with the Uniontown Fire Department, the Creston Police Department and was a volunteer with the Atwater Fire Department.
 - John R. Fritz, John R Fritz, passed away on duty at Austintown Fire Station #1, on June 27,2016 Firefighter Fritz, age 48, ran several emergency calls throughout his shift, and when he did not report to the truck for an emergency medical response, his crew found him in the station unresponsive. Fellow responders and LifeTrans Ambulance provided medical assistance but Firefighter Fritz did not regain consciousness.
 - Adam Long, Firefighter, age 44, of the Defense Supply Center Columbus Fire and Emergency Services, suffered a massive cardiac arrest while on-duty on October 31,2016. Fellow responders treated Long and transported him to the hospital, but despite all efforts, Firefighter Long passed away.
 - Firefighter Ruben E. Mast, age 43, of the Wayne Township Volunteer Fire Department, was responding to an alarm in his privately owned Ford F-250 pickup truck on December 19,2016 when he lost control of the vehicle and struck

a guardrail before overturning. Mast was reported to have been ejected from the vehicle. He was transported by Wayne Township Volunteer Fire Department and Smith Ambulance to Union Hospital in Dover, where he later succumbed to his injuries

After attending an earlier fire department training meeting, Assistant Chief Rodney D. Baker, Jr., responded to a grass fire at 2229hrs on March, 15, 2018. Chief Baker (Chief 51) was first on scene as the commanding officer for the incident and was back in service at 2336hrs. The following day, while attending a family event, Chief Baker became ill and collapsed at 1638hrs. Family members trained in CPR immediately came to Chief Baker's aid while the Pioneer Fire Department and Williams County EMS were called to the scene. Assistant Chief Baker was transported to Bryan hospital where, despite all efforts, he later passed away from a reported cardiac event.

 Joseph M. Patterson, Age 33, Firefighter/EMT, Paint Creek Joint EMS/Fire District, June 24, 2018

Firefighter/EMT Patterson was working with compressed air cylinders at the Paint Creek Joint EMS/Fire District Station 22 when he was critically injured by one of the cylinders. He was airlifted to the Kettering Medical Center where he passed away from injuries sustained in the accident.

• Mark R. Reel, Age 56, Firefighter/Paramedic, Cleveland Heights FD, September 7, 2018

Died in the line of duty as a result of occupational cancer.

• Robert A. Hetzer, Jr., Age 56, Fire Fighter/Paramedic, Dayton FD, October 26, 2018

Died in the line of duty as a result of occupational cancer.

 Darrel L. Wasmer, Age 64, Fire Fighter/Paramedic, Liberty Township (Powell) FD, November 5, 2018

Died in the line of duty as a result of occupational cancer.

 Daniel J. Lucius, Age 33, Firefighter, Carroll Township Fire and EMS, November 15, 2018

While responding to an emergency medical call, Firefighter Daniel Lucius was involved in an accident when he lost control of his vehicle and crashed into a pond. Emergency responders quickly responded to the accident scene and were able to pull Lucius from the submerged vehicle. Lucius was transported to

Magruder Hospital in Port Clinton, Ohio, where he was pronounced deceased from the injuries sustained.
